## INDEMNITY

### 3. Period of indemnity.

The **Indemnitor's** liability under this indemnity shall commence upon the date of appointment of the **Authorized Inspector** by **SANSOR**, and will continue as long as the said Inspector is authorized by **SANSOR**.

**4. Warranty of authority.**
